Welcome!

The Florence Old Town Market, The Port of Siuslaw, The Merchants of Old Town, and the town of Florence Welcomes you and invites you to participate in our Weekend Market. The 2009 Market Season will take place EVERY SATURDAY AND SUNDAY from May 23rd Memorial Weekend through June, July, August, September and October. We are a first come, first serve venue however, we have selected a specific area for the food court, which will be at the east end of the footprint.

We are offering reserve spaces for a fee of \$100.00 this reserves your spot for every market. For your convenience The Florence Old Town Market can take credit cards, checks or cash. Enclosed you will find some general terms and an agreement for you to review and fill out. On the bottom you will find contact information for Richard Wiget who is the Market Manager.

For any emergencies, we have included phone numbers for both the police, Siuslaw Fire and Rescue, and Paramedics. With that, we welcome you and look forward to getting to know you over the season of festivities.

General Terms:

If you do this professionally, it is expected that you have general liability insurance. If so, Please furnish us with a cover letter of your agreement. You will also find in this packet a general liability waiver that all vendors must sign regardless on if they have their own insurance or not. You can bring pets if you are not a food vendor, but you must be fully responsible for your animal. Pets must be on a leash or in a crate. No Alcohol, No loud music.

Please keep booths neat and tidy all vendors are responsible for removing garbage with their vehicle or if it's minor amounts, there are trash-cans provided.

Food Vendor Terms:

As a professional food handler, we expect that you have general liability insurance and current catering license. Please include a copy of both documents with this application or fax to the Florence Old Town Market with a cover page.

Due to the fact that we are trying to minimize non-biodegradable objects in our landfill and our watersheds, we would prefer that you make the effort to use biodegradable cups, silverware and plates only. All vendors will be responsible for removing grease, ashes, or waste from the premises.

You must have a wash station. Fresh water is available. Food handlers have to wear plastic gloves. List the food handlers on your application. It is your responsibility to notify the organizers of the event if you change personnel.

Market Hours:

Saturday 10am to 6pm, Check in by 8am --- Sunday 11am to 5pm, Check in by 9am

Market Dates:

Every Saturday And Sunday May 27th through the end of October.

Reserve Vendors:

To keep your reserve space you must do one market per month during the season. You will be allowed to have one vacation month. The management may add a sick month.
